- HARG uses email to communicate with its members for both formal and (optionally) informal communications. After acceptance of your application, HARG will create an account which you are required to activate. You have the option of forwarding all email to your own preferred email address. You are responsible for the safekeeping of the HARG account and any email or website update using your HARG address is deemed to be from you.
- If the obligations under the Associations Incorporation Act are not complied with the Association can be wound up.

OTHER INFORMATION

- If your application is accepted you are entitled to inspect and make a copy of the rules (constitution) of the association under section 28 of the Associations Incorporation Act.
- If your application for membership is rejected by the members under rule 5, you may give notice of your intention to appeal within 14 days of being advised of the rejection. The Association in a general meeting, no later than the next annual general meeting, must give you a reasonable opportunity to be heard or to make written representations to the Association.
